BURSA NİLÜFER MUNICIPALITY PRIVACY AGREEMENT**

(Privacy Agreement for the Nilüfer Her Yerde Application)

1. Content and Intellectual Property Rights

All content available on the website of Nilüfer Municipality (including text, visuals, design, software, and code) is the property of the Municipality. Such content may not be copied, reproduced, published, modified, or used in any other medium without prior written consent. Users may only view and print site content for personal use.

2. System Security and User Obligations

Nilüfer Municipality takes necessary technical measures to ensure the security of its website. However, users are responsible for protecting their own devices against malicious software. The user is responsible for any issues that may arise on their devices due to the use of the website.

3. Informational Nature

All information provided on the website is for general informational purposes only. Although Nilüfer Municipality exercises due care regarding the accuracy and timeliness of the information, it does not accept any liability for consequences arising from the use of such information. For official procedures, users should contact the relevant municipal units.

4. Changes to Services and Content

Nilüfer Municipality reserves the right to modify or discontinue the content, services, and terms of use of the website without prior notice. Additionally, data stored in the system may be deleted or updated in accordance with applicable legislation.

5. Legal Processes and Competent Authorities

In line with requests from authorized public institutions and organizations, or in cases where unlawful use is detected, Nilüfer Municipality reserves the right to share relevant user information with legal authorities.

6. Data Security and Limitation of Liability

Nilüfer Municipality takes the necessary technical and administrative measures to ensure the protection and security of personal data. However, due to the nature of the internet, no system is completely secure. Therefore, users are also required to take necessary precautions against potential risks.

7. Collected Data

During the use of the website, certain technical data not directly belonging to the user (such as IP address, browser type, operating system, access information, etc.) may be automatically collected. These data are used to improve service quality.

8. Use of Cookies

The Nilüfer Municipality website may use cookies to enhance user experience. Cookies enable the collection of statistical data regarding site usage. Users may control or disable cookies through their browser settings.

9. Protection of Personal Data

Nilüfer Municipality processes personal data in compliance with the Personal Data Protection Law No. 6698. Personal data are processed in accordance with the law and principles of good faith, for specific and legitimate purposes, in a limited and proportionate manner, and retained for the period required.

10. Sharing of Personal Data

Personal data belonging to users are not shared with third parties except for legal obligations. However, they may be shared with authorized institutions and organizations as required by law. Anonymized data may be used for statistical purposes.

11. Legal Validity

This Agreement is governed by the laws of the Republic of Türkiye. The invalidity of any provision shall not affect the validity of the remaining provisions.

12. Acceptance and Entry into Force

All users who access and use the Nilüfer Municipality website shall be deemed to have read and accepted the provisions of this Privacy Agreement.
